Budget: Reviewed last year's budget. We went over income and expenses. We had some discussion about where improvements are needed. We started a line by line review of the budget for consideration. We are losing money each year due to unpaid fees from students. This is putting the organization in jeopardy. There was much discussion about what to do about unpaid fees and how to move forward. We will approach Doc. with these issues and discuss at length during the next booster meeting. We cannot continue to operate like this or we will run out of money. We were only able to get through part of the budget until we address some of these issues. We will finalize the budget in February.

Concession Stand- the permit was paid for the concession stand. We need to find out who paid it. Also, James talked about setting up a meeting with the other booster groups to talk about concerns with the concession stand.
